<b>PURPOSE OF THE POSITION</b>	<ul style="list-style-type: none"> <li>▪ The nurse works in partnership with patients and their families / whanau and collaborates with the multi-disciplinary team in both the primary and secondary health settings, to provide quality nursing care that is safe, cost effective and in accordance with professional, organisational standards, policy and procedure.</li> <li>▪ To provide nursing care in line with the Nursing Council of New Zealand (2007) Competencies for the Registered Nurse Scope of Practice and the New Zealand College of Mental Health Nurses Standards of Practice (2012)</li> <li>▪ To support the delivery of the Hawke's Bay Health Sector vision and organisational wide KPI's e.g. Manatū Hauora Ministry of Health (MOH) targets, financial targets.</li> </ul>
